- Customers can map on-premises licenses to equivalent Oracle Cloud services based on Oracle's **PaaS and IaaS Universal Credits Service Description**.
- BYOL supports Oracle Cloud at Customer, extending cloud functionality to on-premises data centers.
- BYOL can also be utilized with **AWS, Azure, and Google Cloud Platform**.

- Oracle's **Universal Credit Model (UCM)** allows BYOL customers to pay for cloud services based on OCPU usage.
- With Oracle's **BYOL-to-PaaS** program, customers can apply on-premises licenses to Oracle PaaS services.
- **License Mobility** enables flexibility to move licenses between on-premises and cloud environments.
- The **Multitenant requirement** for BYOL with Autonomous Database (ADB) has been lifted, simplifying adoption.
